

**Pacbrake Limited Warranty Rider  
and Limitation for High Mileage Vehicles**

# Warranty

As stated in Pacbrake Limited Warranty as outlined in form numbers L3014, L3019 and L6133, Pacbrake Company has provided certain express but limited warranties and limitations of remedies with respect to product failure. The extent of the repair or replacement coverage is further limited, as provided below, based upon the mileage of the vehicle at the time of installation.

If the vehicle has any power enhancements, or engine modifications other than the LoadLeash, all warranties set forth are void.

Warranty registrations are required to be completed either online or via mail using the provided warranty card in your Pacbrake product kit. All warranty registrations must be submitted within 30 days of the installation date.

Engine brakes installed on a new or used vehicle with mileage of less than 100,000 miles (less than 161,000 km) at the time of first installation carries coverage of 100% of labor and repair cost of warranty work as described in the applicable limited warranty.

Engine brakes installed on a used vehicle with mileage between 100,000 and 200,000 miles (161,000 and 321,869 km) at the time of first installation carries prorated progressive damage coverage of 90% of labor and repair cost of warranty work as described in the applicable limited warranty.

Engine brakes installed on a used vehicle with mileage between 200,001 and 300,000 miles (321,870 and 482,803 km) at the time of first installation carries prorated progressive damage coverage of 80% of labor and repair cost of warranty work as described in the applicable limited warranty.

Engine brakes installed on a used vehicle with mileage between 300,001 and 400,000 miles (482,804 and 643,737 km) at the time of first installation carries prorated progressive damage coverage of 75% of labor and repair cost of warranty work as described in the applicable limited warranty.

Engine brakes installed on a used vehicle with mileage between 400,001 and 500,000 miles (643,738 and 804,672 km) at the time of first installation carries prorated progressive damage coverage of 50% of labor and repair cost of warranty work as described in the applicable limited warranty.

Engine brakes installed on a used vehicle with mileage between 500,001 and 600,000 miles (804,673 and 965,606 km) at the time of first installation carries prorated progressive damage coverage of 30% of labor and repair cost of warranty work as described in the applicable limited warranty.

No engine damage coverage shall be provided for used vehicles having beyond 600,000 miles (965,606 km).
